

Guidelines for Applicants

Teikyo-Harvard Program

1. Enrollment capacity

The maximum enrollment capacity is thirty (30) students.

2. Eligibility

(1) Applicants who hold a bachelor's degree or higher.

(2) Those who are considered as having the same level of academic competence as a bachelor's degree holder.

3. Course Types

Applicants must choose either an audit course or a credit course.

Please carefully note the distinctions between these two options.

(1) Applicants may register for up to five courses. Please note that once course sections are

confirmed, no changes will be permitted.

- (2) Each course consists of eight 90-minute sessions.
- (3) For credit courses, an examination is required. Students who pass will receive one credit and an official transcript.
- (4) Auditing students will not be awarded credits.
- (5) All classes and examinations will be conducted in English. A minimum English proficiency level of CEFR B2 is recommended.

5. Documentation

Applicants from abroad must submit the following documents:

a) **Letter of recommendation**

A letter from a school or institute is required. Please include the following information.

- Full name of the applicant
- Name and title of the dean, president or equivalent authority
- Name of the school or institution

b) **Photocopy of passport**

c) **Copy of diploma** (applicants from non-affiliated schools only)

An official copy of graduation certificate (diploma) from your higher education institution.

\*Please note that Teikyo University may request additional documents if necessary.

6. Enrollment Period

The enrollment period is from January 1, 2026 to January 31, 2026.
